We enclose a copy of the Board of Administration's Decision in the above matter. Please be advised that this Decision was made on September 18, 2024, pursuant to the Administrative Procedure Act (Government Code section 11370, et seq.) and California Code of Regulations, Title 2, sections 555-555.4.

Any party who participated in this case and is dissatisfied with this Decision has the right to petition the Board for reconsideration, and/or to appeal the Decision to superior court (Government Code sections 11521 and 15523). A Petition for Reconsideration and/or Petition for Writ are additional appeal process options available to you. You do not have to file a Petition for Reconsideration to file a Petition for Writ in superior court (Government Code section 11523). Both appeal processes are explained further detail below.

## **Petition for Reconsideration**

Should you decide to petition the Board for reconsideration, your Petition must be *received* by the CalPERS Board Services Unit by October 18, 2024, in order to be included in the Board's agenda for its November 20, 2024 meeting. If your Petition for Reconsideration is not *received* by October 18, 2024, the Board will not be able to act on it and the enclosed Decision will become final. Once the effective date of the Decision has passed, the Board loses the authority to reconsider its Decision, and any Petition for Reconsideration filed after the expiration date will be rejected (Government Code section 11521).

Please title your submission "Petition for Reconsideration" and ensure that all personal information has been redacted (e.g., address, phone number, CalPERS ID number, Social Security number), because it will become a public document when included on the Board's agenda. Your Petition for Reconsideration should be no longer than six pages, legible, signed and dated.

## Petition for Writ of Mandate

If you do not file a Petition for Reconsideration or if your Petition for Reconsideration is denied, another option in the appeal process is to file a Petition for Writ of Mandate in superior court.

If you choose to file a Petition for Writ of Mandate, please submit a written request to our office for preparation of the administrative record. You are responsible to pay the costs to prepare the record, which is calculated at \$0.10/page.

A Petition for Writ of Mandate must be filed in superior court within 30 days after the last day on which reconsideration can be ordered (Government Code section 11523). Once you request and pay for CalPERS to prepare the Administrative Record, your time to file a Petition for Writ is 30 days after the Record is delivered to you (Government Code section 11523).

The deadlines for filing a writ petition are strict. Superior courts have numerous court rules regarding filing Petitions for Writ of Mandate. You may, but are not required to, consult with an attorney should you decide to file a writ in superior court.
