# **Circular Letter**

December 4, 2013

## TO: ALL PUBLIC AGENCY EMPLOYERS

### SUBJECT: IMPLEMENTATION OF AB 1222: PEPRA EXEMPTION FOR TRANSIT EMPLOYEES

The purpose of this Circular Letter is to provide employers with information on AB 1222 and the necessary steps an agency must take to identify its agency as impacted.

Assembly Bill (AB) 1222 (Chapter 527, Statutes 2013) was signed by Governor Brown on Friday, October 4, 2013. This urgency bill exempts California transit employees of public employers from all of the provisions of the Public Employees' Pension Reform Act of 2013 (PEPRA), until January 1, 2015, or until a court determines that the provisions of PEPRA do not violate specified federal transit labor laws, whichever is sooner.

## **Eligible Transit Agencies**

This legislation allows for a PEPRA exemption for eligible transit employees from public agencies subject to Section 13(c) of the Federal Transit Act. To provide appropriate my|CalPERS modifications and notifications for each impacted agency, the first step is for impacted agencies to self-identify as an employer in receipt of these federal grants and subject to AB 1222.

Employers should submit a letter on your agency's letterhead to CalPERS identifying your agency as subject to AB 1222. Sample language is provided below:

## AB 1222 PEPRA Exemption for Transit Employees

Our agency is a transit agency that receives federal transit funding and is subject to Section 13(c) of the Federal Transit Act located at Section 5333(b) of Title 49 of the U.S. Code (49 U.S.C. § 5333(b)). Further, our agency has transit employees who are compensated through funds received under federal transit grants. Accordingly, we hereby notify CalPERS that our agency is impacted by AB 1222, which exempts public employees whose interests are protected by Section 13(c) from the Public Employees' Pension Reform Act of 2013 (PEPRA), and request that CalPERS acknowledge our status as such. Once the self-identification letter is received and processed in my|CalPERS by the Retirement Contracts Services Unit, a letter will be mailed to your agency detailing the process of certifying your impacted staff and modifying their enrollment within my|CalPERS to reflect the classic benefit package. We anticipate processing each letter within 30 days of receipt.
